RELEASE WAIVER

Applicants under age 18 must have parent or guardian complete Parts "A" & "B", 18 and over complete Part "A" only.

PART "A" – WAIVER & RELEASE FROM LIABILITY

In consideration of being permitted to enter for any purpose any RESTRICTED AREA (herein defined as the areas to which admission by general public spectators is prohibited and in addition, consisting of the planned route, or any other area which the participant chooses to access by any mode of transportation), or being permitted to compete, officiate, observe, work for, or any purpose participate in any way in the event, EACH OF THE UNDERSIGNED for himself, his personal representatives, heirs, next of kin, acknowledges, agrees and represents that he has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted area or areas and all portion thereof which he enters and with which he comes in contact, and he does further warrant that his entry upon such restricted area or areas and his participation, if any, in the event constitutes an acknowledgement that he has inspected such restricted area and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use, and he further agrees and warrants that if, at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the restricted area(s):

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the Iowa Sports Foundation, d/b/a Iowa Games, its affiliated clubs, the National Sports and State Governing Bodies, Iowa State University, the State of Iowa, the City of Ames, Story County, the City of Boone, Boone County, and every other city, county municipality, or governmental entity in which an event or activity shall be located, their respective administrators, officers, directors, representatives, agents, coaches, the promoters, hosts, other participants, operators officials, any persons in a restricted area, sponsors, advertisers, owners and leasees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "releases" from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the restricted area, and/or competing, officiating in, observing, or working for, or for any purpose participating in the event;

2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, costs they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

4. EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities at the event and in the restricted areas are dangerous and involve the risk of serious injury and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

5. In the event that I sustain injury or illness while competing in the Iowa Sports Foundation, d/b/a Iowa Games, hereby authorize any emergency first aid, medication, medical treatment or surgery deemed necessary by licenses medical personnel. I also give my permission for attending medical personnel to execute on my behalf my permission forms or other necessary medical documents and to act in my behalf if I am not immediately available to do so.

6. Hereby consent to allow my picture and/or voice or likeness to appear in any official documentary, promotional, exclusive television, radio or film coverage of the Iowa Sports Foundation, d/b/a Iowa Games in any manner incidental to my participation in the Iowa Sports Foundation, d/b/a Iowa Games and without compensation to me.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements, or inducement apart from the foregoing written agreement have been made. This waiver, release and indemnification agreement specifically embraces each and every event sanctioned, authorized or promoted by said releasees during the entire season, including, without limitation, local or regional qualifying events, where located, and applies to each and every event, or activity hereinabove mentioned, and has the same effect as if executed after each and every activity or event in which the undersigned participates so that the parties herein intended to be released and indemnified shall be fully and effectively released and indemnified as to each and every event hereinabove described.

IOWA GAMES DOUBLES EVENT RULES

DIVISION DETERMINATION: Participants add up their ages as of January 1, 2022 and divide by 2. This determines the division. Example: Age 10 + age 48 divided by 2 = age 29 which is Handicap Division BW142 (see entry form top right for divisions) There is no age requirement in the Grandparent/Grandchild division.

AVERAGE: Use your HIGHEST current average, minimum of 21 games. If you don't have a current average use '20-'21 final average, minimum 21 games. If you have neither of these use assigned average male-170, female-165, junior 8 & under-100, 9-14 yrs. 140, 15-18 yrs. 160. (USBC Rule 319a-2 does not apply) This entering average will be used for all levels of competition.

ENTRANTS MUST BE USBC CERTIFIED: Participants must be a member in good standing with USBC or must apply for a tournament participation card \$5 prior to entering competition.

LEAGUE QUALIFYING:

Each bowler will pay \$2 and use their league pins over average score for that league. Fill out only one entry per team. Can try two weeks in a row to advance.

CENTER ROLL-OFF – QUALIFYING FOR DISTRICTS:

1. Bowl three games with handicap if in the handicap division or no handicap if in the scratch division. Handicap 100% of 440.
2. Pay bowling fees of \$____per person or \$____per doubles team.
3. 1 of 2 and any fraction in each division qualifies for the District Roll Off.
4. Closing date April 10, 2022.

DISTRICT ROLLOFFS:

1. Doubles athletes who qualify to compete in districts will bowl at the district site listed on the poster for your district.
2. The entry fee is \$25.00 per individual (\$50 per doubles team). There is no additional fee for those who qualify for the State Games of America Finals in Ames.
3. No roster substitutions will be allowed.
4. Grandchildren may advance only once to the state finals with a grandparent and grandparents may advance only once with a grandchild.
5. Bowling doubles competition will be held according to the schedule (dates & times printed at the top right of the entry form) at each district center.
6. Gold, Silver, and Bronze winners in each division in each District will advance to the State Games of America Finals. Bowler may only bowl once in a division at the Finals.
7. Gold, Silver and Bronze Iowa Games Medals will be awarded to the first, second, and third place finishers at the State Games of America Finals. All State medalists from 2019, 2020, 2021 are eligible to reenter Finals if they do not advance from Districts in 2022 for an additional fee.
